

FIRST AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS

OF

SONORAN VISTA

Stardust Development, Inc. being the Declarant under the Covenants, Conditions and Restrictions of Sonoran Vista, recorded on January 23, 1997 at Instrument No. 97-0045100 in the official records of the Maricopa County Recorder (the "CC&R's"), and being the owner along with Diamond Key Homes, Inc. of all of the lots in Sonoran Vista, Stardust Development, Inc. and Diamond Key Homes, Inc. do hereby amend the CC&R's in the following respects:

1. Add to Article III, Section 10, the following:

"Mortgagees are not required to collect assessments."

2. Add to Article IV, Section 1, the following:

"The Common Areas cannot be mortgaged or conveyed the by Association without the consent of at least 2/3 of the Lot Owners, excluding the Developer Declarant."

3. Article II, Section 5, shall be amended as follows by deleting that language which reads:

"Class B. The Class B Members shall be the Declarant and Developer and shall be entitled to four (4) votes for each Lot owned." and replacing that language with the following:

"Class B. The Class B Members shall be the Declarant and Developer and shall be entitled to three (3) votes for each Lot owned."

Except as modified or amended hereinabove, the CC&R's shall

remain in full force and effect.
